Rental Terms and Conditions

1. **Rental Fee:** The Rental fee is \$ _____ [Rental Fee] per _____ [day/hour/week], plus applicable sales taxes; plus Additional Fees if applicable.
2. **Additional Fees:** Includes Smoking Fee (\$100 if the vehicle smells like smoke), Cleaning Fee (\$50 if excessively dirty), Fuel Top-off Fee, Traffic/Parking Tickets Fee, Toll Road Fee, Change of Return Date, Time, or Location Fee, Recovery Fee (15% if the car is not returned on time and requires recovery), and Optional Coverage Fees.
3. **Vehicle Condition and Return:** The Renter agrees that the vehicle is rented in good condition and must be timely returned in the same condition, excluding normal wear and tear. The Renter is responsible for any damage or loss to the vehicle and its equipment during the rental period.
4. **Mileage:** Unlimited miles are allowed.
5. **Insurance and Liability:** The Renter is responsible for maintaining their own adequate insurance coverage. The Renter agrees to provide proof of insurance upon request. In the absence of rental coverage covered by the Renter's insurance and the coverage paid for as Optional Coverage Fees, the Renter is responsible for all charges related to the damage or loss of the vehicle.
6. **Authorized Drivers:** Only drivers listed in this agreement and who meet the rental company's age and driver's license requirements may operate the rental vehicle.
7. **Fees and Charges:** The Renter agrees to pay all rental fees, taxes, and Additional Fees as agreed in the rental contract. A 2.75% processing fee applies for payments made via CashApp.
8. **Use of Vehicle:** The Renter agrees not to use the vehicle for illegal purposes, racing, towing, or transporting hazardous materials.

9. **Security Deposit:** A security deposit of: \$150.00 [Security Deposit] is returned in the event none of the Additional Fees apply, otherwise it can be applied toward the Additional Fees and any cost of damages not covered by insurance, or if any insurance deductible applies.
10. **Indemnification:** The Renter agrees to indemnify and hold harmless the rental company from all claims, liabilities, damages, and legal fees arising out of the use of the vehicle during the rental period.
11. **Jurisdiction:** This agreement shall be governed by the laws of the state where the rental company is located.
12. **Leaving the State:** Renter must obtain authorization before taking the vehicle out of state. Unauthorized travel may result in additional fees or contract termination.
13. **Optional Coverage Fees:** An added daily cost of \$11 covers damage to our car not covered by your insurance. An added daily cost of \$7 covers Personal Accident Insurance. An added daily cost of \$3 covers Personal Effects Protection. An added daily cost of \$8 covers Additional Liability Insurance. Check with your auto and home insurer and credit card for possible duplications, as these fees only cover what is not covered by your insurance, including deductibles.
14. **Credit Card Charges:** The Renter agrees that the car rental company may charge the credit card on file for any late returns, additional fees, or damages incurred during the rental period.
